This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e Upgradation to Senior Secondary Level as per details given below :

The school is directed to ensure that :	
1.	The total number of section of the school after upgradation, shall be restricted to 18 (As per prescribed dimension) out of which, not more than 1/3rd sections may be used to run Senior Secondary classes and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2	The total number of sections after up gradation shall be restricted to 18, of which not more than 1/3rd sections may be used for senior secondary classes.Any further increase shall be subject to prior approval of the board subject to compliance with affiliation bye laws and availability of classrooms of.500 ft dimension.
3	No composite science lab is seen which is mandatory for secondary level students. The school shall create the same and up grade all the 3 science labs , where proper storage, seating and safety features are not seen. Maths lab is not well stocked and has no proper seating arrangement for students. The school shall upgrade all its labs as per SoPs of the Board within 3 months and submit compliance on SARAS.
4	The school has increased the size of library but it needs more improvement.The school shall upgrade its library and sports facilities as per SoPs issued by the Board within 3 months and submit compliance.
5	The school has created a temporary wooden ramp on part of staircase to access the upper floors . Ramps made at entarnce and at other places are also not as per norms, as they are too steep and dangerous. The school shall dismantle such temporary structures and construct

	ramps/install lifts for CWSN to access the upper floors as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
6	The school has shown CWSN toilets on the ground floor only. In these toilets the WC is on a raised platform which will not be accessible to CWSN in wheelchairs/walkers. The school shall modify the same to make them accessible. The school shall construct separate toilets for CWSN, boys and girls on every floor as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS.
7	The general washroom areas in the school are dirty and not well maintained. The school shall clean and whitewash/paint the same and maintain it in sanitary condition and submit compliance of the same within 3 months on SARAS.
8	Failure to submit compliance on the above mentioned points within the prescribed time shall invite financial penalty against the school.
9	The school shall conduct training of its teachers with CoE Bhopal within 3 months and submit compliance.
10	The school shall follow the SoPs of the Board for its labs, library and sports facilities.
11	The school shall get all certificates renewed from time to time and shall not remove the mandatory disclosure section and videography links from its website.

The above sanction is subject to fulfillment of following conditions:-

- The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School is required to apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
- The school to renew mandatory certificates from time to time.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
